6. Eligibility:

6.1 Competitors must hold the nationality of the participating country.

6.2 All participants must be recommended by their national federation or association.

6.3 Age: 19 to 40 years old (born between 2006 and 1985).

6.4 Each team may register one boxer per weight division. Weight category cannot be changed after registration.

7. Competition Rules

The tournament shall follow the latest version of World Boxing competition rules. Matters not covered will be interpreted by the Referee Committee.

8. Competition method:

8.1 Rules: Based on the most recent translation by CTBA; in case of dispute, the English version of WB rules shall prevail.

8.2 Competition system: single elimination system.

8.3 Competition Regulations:

8.3. 1 Event Information

Note: Male athletes will compete without head guards, per current World Boxing regulations.				

8.3. 2 Female athletes must submit a “Non-Pregnancy Declaration” signed by the coach during medical check-up to participate.

8.3. 3 Athletes must bring their 2025 Taipei City Cup Boxing ID, passport, and athlete handbook to weigh-in. Failure to present the required documents will result in disqualification from competition.

8.3. 4 The weight category registered is final and may not be changed. Only athletes who successfully complete both the medical examination and weigh-in will be eligible to compete.

8.3. 5 Daily weigh-ins and check-ups will be held from 08:00 to 10:00 on August 20 and from 08:00 to 09:00 on later days, and Competitions begin at 14:00.

8.3. 6 Men may wear underwear, and women may wear underwear and sports bra for weigh-in. Eating or having items in the mouth is prohibited. No unauthorized personnel, including coaches and referees, may enter the weigh-in room.

8.3. 7 Athletes who fail to appear within one minute of being called to the ring will be subject to disqualification.

10. Awards

10.1 Awards will be presented in accordance with World Boxing Federation regulations.

10.2 The top three in each weight category will be awarded, with both third-place winners receiving equal ranking.

10.3 Athletes must wear their team's official uniform.

10.4 Individual Awards:

- ✧ 1st place: 1 gold medal
- ✧ 2nd place: 1 silver medal
- ✧ 3rd place: 2 bronze medals

10.5 Team Awards:

- ✧ For each division, teams that take part in five or more weight categories are eligible for team awards. The top three teams will be awarded a trophy as recognition.
- ✧ Team ranking calculation:
 - ◆ The rankings are based on the total number of gold, silver, and bronze medals. If the medal count is tied, the team with more medalists in the top five will be ranked higher.
 - ◆ If still tied, rankings will be decided by a point system:
 - 1 point for each win in the preliminary rounds (first and second rounds)
 - 2 points for a semifinal win
 - 3 points for a final win
 - Total points will decide the ranking.
 - ◆ If both medal count and points are tied, teams will share the same rank.
 - ◆ Note: Categories with only one participant and no actual match held will not count toward the team ranking.

10.6 Best Coach Award and Recognition:

In each division, the "Best Coach Award" will be given to the coaching team of the team ranked first in the team competition. One trophy and certificates (for all coaches) will be awarded as a recognition.

10.7 Miscellaneous:

- ◆ Any typo or error on award certificates may be corrected by contacting the administration within 30 days of event closure.
- ◆ Overseas teams may request corrections via email. Late requests will be processed under the association's supplementary procedure, and fees may apply.

11. Invitation Conditions

11.1 Round-trip airfare is at the team's own expense.

11.2 The Organizing Committee will provide accommodation and meals for up to 12 athletes and 3 staff (if under 6 athletes, only 2 staff will be hosted). Extra members are at the team's expense.

11.3 All participants must stay at the designated hotel.

12. International Referees

12.1 Referees will be selected based on recommendations from participating teams.

12.2 The Chief Referee is jointly appointed by the TPBA and the Organizing Committee.

12.3 The Judges Committee will consist of 5 members. The convener is nominated by TPBA. Other members must hold A-class or above qualifications.

12.4 No protests will be accepted as per the latest World Boxing regulations.

12.5 Referees must cover their own air travel; the organizer will provide 5 days / 4 nights of room and board (check-in: Aug 19, check-out: Aug 23).

12.6 Daily allowance: USD 100 per working day.

13. Liability & Insurance

13.1 The organizing committee is not responsible for injury, loss, or accident. Each team is liable for its own members.

13.2 All teams must ensure:

- (a) All participants sign and complete the registration form.
- (b) The organizer aids in arranging proper insurance for all participants.

13.3 Incomplete or unsigned forms or lack of insurance will result in disqualification.

14. Attire and Protective Equipment for Coaches and Athletes

14.1 All equipment and facilities used in the competition must follow the regulations of World Boxing.

14.2 Coaches are required to wear appropriate sports attire during the competition.

14.3 The organizer will provide boxing gloves, headguards, and hand wraps.

14.4 Athletes must prepare the following gear according to World Boxing standards:

- ◆ Groin protector
- ◆ Mouthguards (red or partially red mouthguards, or those like red, are not allowed)
- ◆ Headscarf (for female athletes)
- ◆ One set each of red and blue competition uniforms bearing the name of the participating unit (no stickers or handwritten labels allowed) Athletes without proper equipment will not be allowed to compete.

15. Meetings

15.1 Technical Meeting: Scheduled for 14:00 PM on August 19, 2025, on the 1st Floor, Taipei Gymnasium (Address: No. 10, Sec. 4, Nanjing East Road, Taipei City). The match draws will take place at once after the meeting.

15.2 Referee Meeting: Scheduled for 4:00 PM on August 19, 2025, also on the 1st Floor, Taipei Gymnasium (same address).

(Any changes to time or venue will be announced separately.)

16. Draw

16.1 The draw will be conducted during the team managers' meeting. All teams must send a representative to attend.

16.2 If a team does not send a representative, the draw will be conducted by the technical delegate or a staff member appointed by the organizer.

16.3 Decisions made during the managers' meeting may change the drawing order.

17. Weigh-In

17.1 Weigh-ins must follow official rules. Male athletes may wear underwear, and female athletes may wear sports bra and underwear. No eating, drinking, or chewing is allowed during weigh-in. Only those who pass both medical check and weigh-in will be eligible to compete.

17.2 When requested by the organizer, athletes must provide valid documents to verify their age. Refusal to do so may result in disqualification.

17.3 Female athletes must download, complete, and sign a Non-Pregnancy Declaration (along with their coach) from the official website before the competition, and send it during medical check for record.

17.4 Only one official weigh-in will be held. Failure to meet weight will result in disqualification. Athletes may conduct a trial weigh-in outside the weigh-in room beforehand.

18. Transportation

18.1 The organizer will provide shuttle bus transportation for all participating teams arriving at Taoyuan International Airport or Taipei Songshan Airport. Airport pick-up to the hotel and return transportation after the competition will be arranged by the organizer.

18.2 The organizer will also provide round-trip transportation between the hotel and the competition venue, as well as for other official scheduled events.
